DR IGNACIO SILVA is Associate Professor of Science and Theology at the Philosophy Institute, Austral University, Argentina, and Co-Director of the PhD and MA programmes in Philosophy of Natural and Cognitive Sciences at the same university. Formerly a Research Fellow at the Ian Ramsey Centre for Science and Religion and a member of the Faculty of Theology and Religion, University of Oxford, Dr Silva has co-directed research projects for over \$3.5M of grants involving scholars in more than a dozen countries in Europe, Latin and North America. Dr Silva has a DPhil in Theology and an MSt in Science and Religion from the University of Oxford as well as degrees in philosophy from the Catholic University of Argentina. A major theme of his research is the understanding of divine providence in relation to research done in science, philosophy, and theology. His publications include work in philosophy of religion, science and religion, natural philosophy and medieval philosophy, featured, for example, in *The Journal of Religion*, *The New Blackfriars*, *Zygon: Journal of Religion and Science*, *The Heythrop Journal*, and the *European Journal for Philosophy of Religion*. In addition to his research at Austral, Dr Silva lectures on philosophy of religion at the Catholic University of Argentina and is an Associate Member of the Department of Theology and Religion (University of Birmingham) and the Ian Ramsey Centre for Science and Religion (University of Oxford).
